

3. Since the Fourth GCG Report, GCG has received one (1) untimely request for exclusion. Attached hereto as Exhibit "A" is a list showing the additional untimely request for exclusion.

4. To date, GCG has received a total of 235 requests for exclusion, of which 222 are timely and 13 are untimely. Of those 13 untimely requests for exclusion, 7 requests are postmarked on or before October 26, 2006 and the remaining 6 requests are postmarked on or after October 27, 2006.
