REPORT ON EXCLUSION REQUESTS RECEIVED


3. As stated in my October 3, 2006 affidavit, GCG has previously received a total of 215 timely requests for exclusion and two (2) untimely requests for exclusion in response to the Nortel I Settlement Notice. Since then, GCG has received an additional six (6) timely requests for exclusion and two (2) untimely requests for exclusion. Attached hereto as Exhibit "A" is a list showing the six (6) additional timely requests for exclusion and two (2) additional untimely requests for exclusion received since my prior affidavit.

REPORT ON OBJECTIONS RECEIVED

5. As stated in my affidavit, as of October 3, 2006, GCG had received a total of 35 timely objections in response to the Nortel I Settlement Notice. Since then, GCG has received one (1) timely objection and five (5) untimely objections, copies of which are attached hereto as Exhibit "B".

INTERIM REPORT ON PROOFS OF CLAIM RECEIVED

7. As of October 3, 2006, GCG had received a total of 51,196 Proofs of Claim. While the deadline is still over a month away, to date GCG has received an additional 18,547 Proofs of Claim for a total of 69,743 Proofs of Claim to date.
